Taryn Kryzda - County Administrator - Retiring

When I began my career with the Martin County Board of County Commissioners 35 years ago, the County's population was 90,000 and we had 437 employees. Moving from Jupiter where I grew up, Martin County was pretty much an unknown for me, except for the exceptional school system which was why the move was made here, allowing my oldest child to begin Kindergarten in Martin County. Today, we have about 161,000 residents that we serve with 1,100 employees. I have had the distinct pleasure to serve the County as the County Administrator for a total of 13 years, a record that I am proud of, as the prior long tenured County Administrator was with us for 8 ½ years before accepting other employment.

In 2003 when I went through LEADERShip, I was a department director and wanted to be more connected to my community. I was encouraged by others to apply to the program, I am grateful that I did, and was accepted to be a participant of Class 13. The LEADERShip motto "You Can Make A Difference", stands true, I believe it, and keep it at the forefront in making decisions. Martin County has been good to me, and as I get ready for retirement, there are moments of reflection that give me a true feeling of satisfaction.

I am proud of so many accomplishments that we have been able to achieve. And when I say we, I mean it, I am fortunate to have an exceptional team that I work with and know they will continue to flourish even after I retire. But, with that said, it takes support of our top leadership, the Board of County Commissioners, who are making those policy decisions we get to implement and keeps us unique. Having a career of life impacting experiences: Hurricanes Francis & Jeanne, a recession and state mandated reductions which cut personnel and the services we were providing, blue-green algae outbreaks, pandemics, and a multitude of other events, has provided me with many opportunities for which I am extremely appreciative.

Being the first Martin County Administrator to retire since the position was created in 1971, I will cherish all the positive memories and the relationships that I have had the pleasure to develop, and would possibly never have had that amazing experience had I not been provided the multitude of opportunities that this position has afforded me. Once I retire the end of June, I plan to stay connected to the community, and will look for those opportunities where I can make a difference.
