Students Learn Lessons on Law and Fire Safety

Students met professionals from the 19th Judicial Circuit Court of Florida, including State Attorney **Tom Bakkedahl** (10), the Honorable Judge Jennifer Waters and Assistant Public Defender **Robert Bruton** (26) at the Martin County Courthouse. The three presented an overview of the court system in Martin, St. Lucie, Indian River and Okeechobee Counties. Students were also given solid advice in making smart choices during their student years, and how to prepare for the many varied careers in the legal arena.

The students visited Martin County Fire and Rescue, touring the station and vehicles and learning about life as a firefighter and EMT. The class visited the Martin County Sheriff's Office and Correctional Facility. Students enjoyed a K-9 presentation from "Maverick" and his handler, Cpl. Ronald Manganiello, While learning how German Shepherds are trained to assist officers in tasks vital to law enforcement. Chief Deputy **John Budensiek** (30), spoke to the students encouraging them to never give up, never set goals too low, and build upon their successes one layer at a time.

They had a brief tour of the jail, led by a MCSO Deputy. The students learned how inmates are brought to and processed at the MCSO jail and saw firsthand about the complete lack of rights and privacy one should expect if in jail. They also viewed the pods of the newly renovated wing of the jail, and saw the small space in which up to 32 inmates live, sleep, eat, shower and cohabitate.
