Youth Health & Wellness Day

Martin Youth LEADERship's Class 26 took part in Health and Wellness Day on Feb. 18. The day was chaired by Charlene Lyons, class 25 (CEO of the **YMCA of the Treasure Coast**), with the help of David Sarno, class 21, (Vice President of Commercial Lending for Valley National Bank). The day kicked off at the Y with vigorous exercise training led by YMCA Sr. Fitness Director Tressa Everett, and Membership Director Brandon Welz.

Students then traveled to the **East Stuart Community Center**, where Jessie Adamson from Tykes & Teens led them through interactive exercises discussing mental and emotional health stability. Following this, students received an education about the dangers of alcohol, DUIs, narcotics and other crimes from the **Stuart Police**. Social worker Kathleen Lannon, class 21 and Corporal Amy Durant and Rachel Minor spoke about the legal and practical consequences of DUIs and underage drinking. The lesson became very clear: that it takes very little alcohol to become too impaired to make good decisions or drive.

The students had the opportunity to learn how to budget, prepare and clean up their own nutritious lunch, thanks to the guidance of nurse and certified diabetes educator Marybeth Pena, Health and Social Services Coordinator from the **Hope Center for Autism**. The day concluded with a brief lesson from Lisa Madden, yoga instructor from the **YMCA**.

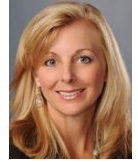

CFP, (18) have changed their team name from Sailfish WM to Dadko Wealth Management. They continue to Create Financial Clarity.



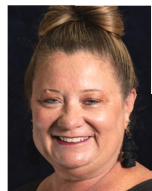
