Alumni Community Ambassador - Cher Fisher

Cher Fisher is a proud LEADERship Class 29 Graduate. After retiring from a 28-year career as an account executive with a leading title insurance company, traveling all of south Florida, she wanted to discover more about her hometown of Stuart, a resident since 1989.

Among her several forays into community service, she joined Kiwanis Club of Stuart in 2015 and became President of the successful club after her retirement, for an unprecedented three year term, from Oct 2019 to Oct 2022.

During Cher's term as President, the club enjoyed several major accomplishments. For the first time in the 70 plus life of the club, Kiwanis Club was designated as the State Club of the Year, among almost 300 clubs in the state! Notable for the club and the community was the renovation of its youth park in downtown Stuart. The \$285,000 renovation featured a "tot lot" for 2-to-5 year-old children and a Sensory Sensitive Garden play area for children with autism, sensory or physical issues. The Community Build Day was held early 2022, and neighbors, police officers, firefighters, community leaders, and Kiwanians worked together to put together the renovation in record time.





Cher is thrilled that her and her club's vision to finish the final phase of the park, for older children 5-12, will be completed within the first quarter of 2024. The City of Stuart owns the property upon which Kiwanis Park is situated and has donated toward the funding the club has raised to ensure the project is completed.
