# COMMUNITY CORNER

Hi LEADERS! I'm excited to kick off this Community Corner in our July 2025 LEADERlines issue. It's a chance for me to brag about the great work your county does in supporting some of its most vulnerable residents.



In my department, Martin County Human Services, we also have two other LEADERship graduates: our Director, Michelle Miller (Class 31), and Phil Ratchford, our Grants Manager (Class 34).

I'm the Human Services Manager at Martin County Human Services. In this role, I supervise the case management of Adult Drug Court and Mental Health Court, as well as the Juvenile Civil Citation, REACH, and Delinquency Diversion programs. In addition, I supervise our Martin County Drug Lab, the Martin County Community Action Coalition, our IRSC interns, and management of the county Opioid Settlement Funds. You may not have even known that we have these programs—but wait, there's more!

In addition to the 10 people I supervise, we have employees dedicated to housing-related concerns such as the Community Services Block Grant and the SHIP program. We are dedicated to reducing the incidence of homelessness in Martin County through a variety of programs, such as electricity bill assistance, water bill assistance, even indigent cremation services. We also implement the Tobacco-Free Florida and Mental Health First Aid grants. Our Veterans Services do a phenomenal job of helping our veterans connect to the benefits they deserve. We also offer free trainings to the community: Mental Health First Aid, QPR (suicide prevention), and WISE—a curriculum for senior citizens and their caregivers. Let me know if you'd like any of these trainings for your community or business!

If that sounds like a lot, you're right—it is! As a team, we regularly help each other so that the response to our citizens is fast and effective. If we don't provide the service you need, we enjoy connecting you with a resource that can help. We also enjoy any excuse to bring treats for a staff breakfast or lunch. If you visit—be assured that there's an ample supply of chocolate somewhere close by!
